Note: The submission date for receipt of IWA applications has been changed by State Statute to be the day immediately before a regular meeting. However, to allow time for review of applications prior to the regular meeting, the IWA will not discuss or take any other appropriate action on applications submitted less than five business days before a regular meeting. Thank you in advance for planning your application submission accordingly.
2. The Planning and Zoning Commission meets generally on the first Wednesday of the month, at **7:00 p.m.** in the Commission Meeting Room of the Town Hall, 40 Peck Road, unless otherwise posted.
Note: The submission date for receipt of PZC applications has been changed by State Statute to be the day immediately before a regular meeting. However, to allow time for review of applications prior to the regular meeting, the PZC will not discuss or take any other appropriate action on applications submitted less than five business days before a regular meeting. Thank you in advance for planning your application submission accordingly.
3. The Zoning Board of Appeals meets on an “as-needed basis”, generally on the second Monday of the month, at **7:00 p.m.** in the Commission Meeting Room of the Town Hall, 40 Peck Road, unless otherwise posted.
Note: To allow time for required legal notices to be posted, complete applications must be submitted no less than ten business days before a regular meeting. Thank you in advance for planning your application submission accordingly.
