However, to allow time for review of applications prior to the regular meeting, the PZC will not discuss or take any other appropriate action on applications submitted less than five business days before a regular meeting. Thank you in advance for planning your application submission accordingly.
3. The Zoning Board of Appeals meets on an “as-needed basis”, generally on the second Monday of the month, at **7:00 p.m.** in the Commission Meeting Room of the Town Hall, 40 Peck Road, unless otherwise posted.
