### From the First Selectman's Desk September Highlights and October Updates

Dear Bethany Residents,

School got off to a fantastic start on Monday, August 26th with lots of happy faces – children and adults alike. After settling in for the first week of school, everyone was able to enjoy the long Labor Day holiday weekend. Thank you to Superintendent Byrd and her wonderful



staff for all the time, effort and energy that was put into having BCS ready to welcome back students for a new school year. Wishing students, families and staff a great year!

On the afternoon of Friday, September 6th, we were notified of the unexpected immediate resignation of our Interim Parks and Recreation Director. This put us in a very difficult position to continue the before and after-school programs the following week. We worked throughout the weekend to investigate viable options to keep the programs running. On Monday, September 9th, interviews were held with potential candidates, and a continuing conversation was held with representatives from the JCC. Looking at the JCC as the best option, a Special Board of Selectmen meeting was called for Tuesday, September 10th, to discuss and act on engaging the JCC to coordinate working with the Town to assist Bethany Parks and Recreation families who use the before and after-school programs and then forward this recommendation to the Board of Finance for any potential funding that might be required (i.e., bus, fee).

The JCC was willing to open an entirely new section just for Bethany students in the after-school program. They are only able to accommodate a maximum of 46 students based on their license. However, a minimum of 25 students would need to be enrolled for the program to move forward. All families registered with the Bethany Parks and Recreation program were contacted and provided the necessary paperwork to enroll their child/children in the JCC program. As of Friday, September 13th, 40 families had registered for the program to start on Monday, September 16th. Also, a contract is in place to have the JCC run the after-school program for the remainder of the 2024-2025 school year. Families were provided with the JCC calendar and notified of any exclusionary dates. Vacation weeks will be scheduled separately by the families based on their need. The after-school program at the JCC will run from 3:30p.m. to 5:30p.m. compared to the program in Bethany which ran until 6:00p.m.

The JCC's daily rate is \$30 per day versus Bethany's program which was \$12 per day. However, we were able to negotiate the rate down to \$20 per day for Bethany Parks and Recreation families participating at the JCC. This now requires bus transportation which will cost approximately \$180-\$200 per day to be split 50/50 between the JCC and the Town of Bethany. At its regular monthly meeting on September 10th, the Board of Finance did approve to cover the cost of the bus and pay the \$8 differential for the Bethany Parks and Recreation after-school families only. These costs would work within the current Parks and Recreation Department budget and not require any additional appropriation in funding.

The Town of Bethany employed 20 active before and after-school counselors that the JCC said could be potential additional staff, but they would need to apply for the positions if they chosoe to do so. Those interested would need to go through JCC's hiring and training process independently from their position for the Town of Bethany.

The before-school program: Mrs. Byrd, the BCS Superintendent, was contacted regarding the possibility of having the before-school program being run at the school. On Tuesday, September 10, 2024, it was confirmed that there is a 100 percent confidence level of getting a program together and having it run for the remainder of the 2024-2025 school year. Mrs. Byrd also confirmed that she felt comfortable with having a soft opening on September 23rd for the Parks and Recreation families. The school would register and bill families accordingly.

An additional item on the September 10th agenda was to discuss the overall status of the Parks and Recreation

# First Selectman's Desk

Department. As the before and after-school programs would be operated outside of the Parks and Recreation Department at this time, the Board would be moving forward with the Special Meeting on the 19th that had been previously approved to address the appointment of new members to the Parks and Recreation Commission.

At the meeting on the 19th, the following individuals have now been appointed by the Board of Selectmen to be on the Parks and Recreation Commission: Jaime Dawson-Guthrie, David Pecoraro, Craig Behun, Emily Meredith-Stein, Jennifer Galik, Erik Rooney and Marissa DeFeo. Thank you to these individuals for stepping into this role.

The Parks and Recreation Commission held an organizational meeting on the 25th to address their scope of work, i.e., to review policies and procedures, review the monthly revenue and expenditures reports, help oversee any possible additional programs, i.e., Bethany Hoops, art, cooking and yoga classes for students. Also, looking at the possibility of holding recreational and leisure needs for adults, and the Town as a whole, as well. An initial task was to appoint a Chair, Vice-Chair and Secretary to help run the meetings.

Paving on Almar, Judd Hill, Tollgate and Oak Ridge is complete. Thank you to Tilcon for another wonderful job. A separate crew will be returning to do any backfill and/or curbing that needs to be done. We continue to monitor our roads so that we can stay ahead of any major issues. The Public Works Department works very hard to keep our catch basins cleared of debris and fill any potholes that may occur. If you see any clogged catch basins or notice any potholes, you can call the Public Works Department at 475-238-6966 to let them know.

Just a friendly reminder to lock your cars if they are parked outside, and do not leave valuables in sight. If your car is not locked and you have your garage door remote programmed in your car, you now give someone access to your house. It cannot be stressed enough to be diligent and aware. Some neighborhoods have block watches. If something doesn't seem right, call the police. Troop I Barracks is 203-393-4200 X0 (available 24 hours a day). The Resident Trooper's office is 203-393-2100 X1129 during regular business hours at the Town Hall.

No matter what time of year: Please remember to make sure your residence is properly identified on your mailbox and/or house. Shared driveways should have a clear direction to each house. Long driveways should have ample clearage on both sides of the driveway for emergency vehicles to access the residential property. Valuable time can be lost in the case of an emergency. Proper identification and access are crucial.

Yes, winter is coming. So, it's never too soon for these reminders: It is never too early to begin preparing for the heating season. Make sure your furnace has been inspected and serviced; have your chimney and vents cleaned and inspected (buildup of creosote is a leading cause of chimney fires). If you use portable heaters, always plug them directly into an outlet (do not use extension cords) and place them at least three feet from anything that can burn. The safest way to know it's off when not in use — unplug it. Test your smoke and carbon monoxide alarms. We want everyone to be safe.

A reminder from recycling: Please DO NOT leave cardboard out with your curbside trash pickup. Cardboard should be taken up to the Recycling Center. For large boxes, they should be cut into sections no larger than 3 ft. square. ALL carboard should be flattened. The trash hauler has been reminded that they are not to take cardboard or other recyclables or bulk trash left out with regular curbside trash pickup. We have contracted with them for municipal solid waste only. Any questions regarding recycling or bulky waste call 203-393-1555.

RWS (our trash hauler) provides a private pick up for recyclables. All participants are provided with a 96-gallon recycling cart. The charge is \$18.99 per month. For more information on this program, you can reach them at BethanyRecyles.com or text them at 203-334-1600.

Hazardous Waste (paints, solvents, chemicals) may be disposed of at HazWaste Central at the Regional Water Authority building on Long Wharf in New Haven. Go to: https://www.rwater.com/in-the-community/hazwaste-central for more information.

# From the Superintendent of School's Desk

BCS K.I.D.S. Program and Before-School Care Update

The Bethany Community School (BCS) team has worked tirelessly alongside Jenn Cafasso from the Town to find safe, affordable, and reli-



able before- and after-school care solutions for families, following the sudden shutdown of the Park and Recreation program. Our collaborative efforts were driven by a shared commitment to ensuring that no family was left without support during this challenging transition.

Throughout this process, we have focused on identifying staff members who would not only meet the program's needs but also reflect the high standards of care and safety we hold at BCS. The selection and training of staff were key to ensuring the program's success. Thanks to the dedication of our team, we are pleased to announce the soft launch of the BCS K.I.D.S Before School Program.

Unfortunately, despite extensive efforts, the BCS K.I.D.S. program was unable to fully launch both beforeand after-school care, as we were not able to secure enough staff for both portions. However, Mrs. Cafasso successfully arranged for after-school care through the JCC, providing families with a vital service. Although the after-school solution did not include a morning option, the BCS administration, based on staff interest, has been able to offer before-school programming.

The BCS K.I.D.S. Before School Program has been extended to families previously enrolled in the Park and Rec morning program. All staff members involved in this program are from the BCS team, ensuring familiarity

and trust. On September 18th, staff members participated in an orientation and planning session, followed by a virtual information session for families on September 19th.

The official "soft launch" of the BCS K.I.D.S Before School Program began on September 23rd with an initial group of students. If additional staff express interest in working within the program, we hope to expand it and increase the number of available slots for more families.

We are also pleased to share that the cost of the morning program is set at \$30, lower than the initial estimate shared in the August survey.

I want to extend a heartfelt thank you to BCS Principal Tom Reed-Swale, Cheryl Kiesel, and Brandy Spargo for the countless hours of hard work they dedicated to making this program a reality. We would also like to recognize the BCS staff members who stepped up to support the families during this time: Jaime Bowen, Eileen Babbitz, Jessica Graham, William Fencl, Vincent Condo, Marissa Saucier, and Maria LeVasseur. Their commitment to our students and families has made all the difference.

We appreciate the community's patience and understanding as we continue working toward long-term solutions for our before- and after-school care. If you have any questions or need further information about the program, please contact us at bcskids@bethany-ed.org.

### Local Boy Scout Completes Hidden Brook Preserve Trai

Liam Hendricks, an Eagle Scout Candidate with Scout Troop 931, has completed building

the Sisyphus Trail in the newly acquired Hidden Brook Preserve. Working closely with the Land Trust Trail Crew for his Eagle Scout project, Hendricks chose the trail route and then directed his team of scouts, family, and friends during the construction phase in August and September.

His team cleared downed trees and brush, built stone crossings over streams and marked the trail using yellow blazes. About 2/3 mile in length, the trail courses through the 36.1-acre Hidden Brook Preserve, a parcel that includes approximately 8 acres of a mix of woodland and rocky outcrops encircling a rich woody marsh, which protects songbirds, wild flowers, and other wildlife.

Starting from the unimproved section of Atwater Road near Russell Road, the trail partially circles the wetlands, runs along nearby stone walls, passes through a stand of huge tulip trees, and climbs to a rocky outcrop overlooking the wetlands. A huge boulder left behind by glaciers that lies on this outcrop served as the inspiration for the trail's name based upon the tale from Greek mythology. The Sisyphus Trail terminates with Falling Water Trail in the Town of Bethany's 74-acre Carrington Preserve.

Liam's final step on his path to becoming an Eagle Scout will be to participate in a Board of Review, which many liken to a job or college interview. Adult leaders of Connecticut Yankee Council, Scouts of America and others will conduct the Board of Review. Once completed and certified, Liam will achieve the prestigious rank of Eagle Scout.

The Bethany Land Trust is grateful to be supported by the Scouts, their parents and leaders and we are always looking to provide the Scouts and other youth groups with opportunities for community engagement.

The Land Trust invites everyone to take a walk in the woods on the Sisyphus Trail. The easiest access is from the unimproved section of Atwater Road where it meets Russell Road. A map is available on the Land Trust website bethanylandtrust.org.

### Monthly Hikes: Early Morning Birding Walk in August

Led by Christin Arnini, retired science teacher, and Chris Howe, president of the New Haven Bird Club, a small group of birders walked through Mendell's Folly, one of the Bethany Land Trust's bird-rich gems on an overcast day in August. Using binoculars and a spotting scope, the group was thrilled to see some water birds like herons, king fishers and cormorants as well as an Eastern Wood-Pewee and Eastern Phoebe. The group of birders also identified birds by their calls using bird identification phone apps. Of note, in bird surveys for the Connecticut Bird Atlas, 2018-2022, 77 total species were seen/heard in Mendell's Folly. Thirty-nine species were confirmed as breeding there, including species declining in many areas such as the American Woodcock.

### It Happened In Bethany

SPERRY ROAD

Sperry Road has seen a lot of history and colorful personalities since it was laid out as one of many grid roads (with adjoining lots) in 1711. Eastern Bethany and Woodbridge were part of the church-run New Haven Colony then. The road wasn't paved or named until the 1930s and it never became a main road.

It was Clifford Whitlock, founder of the Whitlock Bookstore in New Haven, who named many Bethany roads. The enterprising businessman moved to Bethany in 1917 and settled on Sperry Road a decade later. Although the grid of Bethany roads is obvious on a map, Sperry Road developed some twists over the centuries because of terrain, spring mud and structures. Whitlock moved the road about 50 feet away from his house to provide a lawn. "No one asked anyone. You just moved it", said son Gilbert Whitlock. As an early commuter, his father improved the road with hundreds of cinder loads.

Sperry Road's best known landmark is the Whitlock Book Barn, housed in two old farm buildings. Book lovers from near and distant points browse among 50,000 used and rare books and pamphlets, prints, maps, postcards, small collectibles.

Memories include the great blizzard of 1934, which required two weeks of neighborhood shoveling to reach the main road. Another story involved the ax murder of Enoch Sperry near his Sperry Road Mill on New Year's Day 1856. Charles Sanford, the cult-crazed maniac who ambushed Enoch as he walked his horse and sleigh up a hill, killed two others before being cornered with pitchforks.

Several historic houses along Sperry Road were described by Alice Bunton in her book "Bethany's Old Houses and Community Buildings." The Chauncey Tuttle House, later owned by Theodore Sizer, was built in 1799, and overlooked pastures, hills and Bethany Lake.

The Marcus Sperry House, at the Hatfield Hill intersection, predates 1750, making it one of Bethany's oldest.


The Rosella Allen House was built in the 1870s. Rosella reportedly left \$5000 for the obelisk that marks her and her husband's grave. It is, without question, the tallest in town.

The small house at No. 281 incorporated the one-room Beecher School, attended by students from 1870 to 1934. An earlier building had been dated to the 1790s, when Bethany was still part of Woodbridge.

Manson Whitlock recalled walking to the school in all kinds of weather while those farther away were "bussed" in a horse-drawn surrey. The road was dirt track with a grassy median. In spring, it was a quagmire, trapping buggy and car wheels alike.

The Edson Beecher House at No. 248 dates from the 19th century. At Bethway Road, the view opens out to expansive fields, a pond and barns where sheep were a familiar sight when the Yale School of Medicine used the farm for animal research.

The Cyrus Sanford House, at No. 106, dates to the early 1800s. The salt box at No. 28 was built in 1756 on State Street in Hamden and moved in numbered pieces by Reverdy Whitlock. Quite the historic Bethany road....

### **Sustainable Bethany**

No. 46. Letter from Sustainable Bethany. Well Water Testing, Book, Upcoming Events, October Night Skies.

Well Water Testing: Do you ever think about the water from your well? Good tasting water doesn't mean it's good nor safe. It is estimated that ~25% of Connecticut residents get water from private wells. Public water sources, like the Regional Water Authority, which owns land in Bethany and uses water from Lakes Chamberlain and Bethany for the Greater New Haven area are required by the Connecticut Department of Health to follow federal and state laws to test water, to treat when needed, and to share information with the public. Recent federal law added PFAS testing to water quality evaluation in April 2024. But private well owners are on their own. Testing occurs when a well is first installed or when a home is purchased in accordance with Section 19-13-B101 Public Health Code.

Water tests look for minerals, bacteria, and uranium/radon. High levels of iron and manganese stain toilets and laundry. High levels of bacteria cause illness, and uranium and radon can damage kidneys and cause other serious health effects.

**Book Recommendation:** The Light Eaters, by Zoë Schlanger.

Zoë Schlanger takes us on a remarkable journey into the life of plants. Working with botanists she describes how trees change their leaf chemistry to kill feeding caterpillars and alert nearby trees using airborne pheromones. Lima beans send out chemical messages summoning predators of insects that eat the bean plants, male ferns sabotage one another's rainwater swimming sperm using hormones, Arabidopsis plant veins light up in rippling bioluminescence when pinched, older trees share nutrients with younger trees, and plants alter their growth in response to the weather growing shorter in wind. With these examples and more, Schlanger shows us how plants are not background wallpaper to be eaten, bullied, or ignored but dynamic, responsive, even sensitive altruistic planet-wide greenery that can bicker, fight, and defend with the best of us. When you sit down to eat your salad, consider who might be chatting about you outside in the vegetable garden. The trees might say a word or two as well....

October Night Skies: On the 17th the October Harvest Moon is full. In ancient times the Moon's patchy appearance was explained as being a trick of light. In 1609 Galileo for the first time pointed a telescope at the Moon. What he saw was startling. The Moon's surface had what looked like valleys, plains, and mountains much like an unheavenly version of Earth. This led him to search for imperfections in other objects in the night sky. Ultimately, he proved the Earth was not the center of the Universe! The imperfections of the Moon are in three interrelated categories: the dark maria "seas", circular rings, and rays. Despite Galileo finding similarities between Earth and the Moon, it remains an alien world. For example, the huge circles that dot the surface were a mystery. Some scientists over the centuries correctly predicted they were impact craters from meteorites, but most thought right up to the mid-20th century they were ancient volcanic eruptions!

The dark maria were formed by large meteorite impacts causing molten rock to back fill the craters. Maria are darker than the rest of the surface because the volcanic rock is iron rich, which is less reflective than other Moon rock. They are seen as the dark areas of the Moon we variously interpret as the Man in the Moon, Moon Rabbit, female figures, a toad, even Saint George! They're called "seas" because earlier they were thought to be filled with water. As we now know, there is no water on the Moon. The circular rings are the raised edges of hundreds of smaller craters from impacts that were not large enough to create molten rock, and the rays were created by ejected matter radiating from impact craters. So, enjoy our beautiful closest extraterrestrial neighbor.

### From the Assessor's Office

#### PERSONAL PROPERTY DECLARATIONS

Pursuant to Connecticut Statute 12-42, any business owning or leasing personal property within the Town of Bethany must file their Declaration with the Assessor's Office no later than Friday, November 1, 2024. Any declaration received in an envelope bearing a US Postal postmark, as defined in section 1-2a, on November 1, 2024, or before, shall not be deemed delinquent. Extension may be requested up to the end of day Friday November 1, 2024 at 4:00pm.

A twenty-five (25) percent penalty must be imposed on any business that does not file by November 1, 2024. Files without a signature by the business owner or authorized agent will not be accepted.

The following should be reported: machinery and equipment, office furniture and fixtures, computers and computer equipment, vending machines, copiers, non-registered motor vehicles, horses, farm machinery and all other taxable personal property located within Bethany.

All farmers may file an application to the Assessor for exemption of farm machinery, horses, or ponies which are exclusively used in farming. Exemptions will NOT be granted to those not filing an application.

Declaration forms will be mailed no later than September 30, 2024. If you do not receive one, but own taxable business personal property within the Town of Bethany, please contact the Assessor's Office at 203-393-2100 ext. 1112 or come into Town Hall at 40 Peck Road to pick up this form.

**Veteran's** – If your DD214 is NOT on file in the Town Clerk's Office, it must have been filed by September 30, 2024 to be considered for a veterans exemption on the 2024 Grand List.
