### The Team Behind the Town

### Admin Lieutenant: Dave Merriam

I have served the Town as a public safety official after retiring from State Police since 2019, with responsibilities that include coordinating public safety efforts, SRO, maintaining emergency preparedness records, overseeing resident communications related to safety protocols, and acting as liaison between the Town and state law enforcement agencies. My role helps ensure that the community remains informed, prepared, and connected to the appropriate public safety resources.

Constables serve as part-time law enforcement. Their duties often include traffic control, patrol, and providing support during town events or emergencies.

### Kid Friendly Bio-Blitz Hike Sunday July 13th, 1 – 3 PM

Join us for a fun-filled BioBlitz at Whispering Pines Preserve on Sunday, July 13th from 1-3! (NOTE: date change!!!) A BioBlitz is an excit-

ing event where teams of scientists, students, and community members come together to identify as many species as possible in a specific area over a set time period. It's a hands-on way to engage with nature and learn about local biodiversity.

Participants will be surveying plants and animals that inhabit both the stream and nearby forest. Explore this beautiful spot with us and help identify its inhabitants! Your discoveries will be shared with the scientific community via iNaturalist.

### TAX COLLECTOR'S LEGAL NOTICE

The first installment of Real Estate and Personal Property Taxes, along with the full amount of Motor Vehicle Taxes on the 2024 Grand List, is due July 1, 2025. Please note: This will be the only bill mailed for BOTH installments. (Your cancelled check serves as your receipt.) Payments should be mailed to: Bethany Tax Collector 40 Peck Road, Bethany, CT 06524

To avoid interest charges, payments must be received or postmarked by August 1, 2025.

Taxes not paid by **August 1, 2025**, will accrue interest at **1.5% per month**, starting from **July 1, 2025**, until paid in full. The **minimum interest charge is \$2.00 per installment.** (Per Connecticut General Statute §12-146) **Reminder:** Failure to receive a tax bill does **not** exempt you from payment or interest charges.

(Per Connecticut General Statute §12-130) Payments may be made **In Person**: Tax Collector's Office, Monday–Friday, **8:30 AM** – **3:30 PM** (Note: No payments processed after 3:30 PM) If paying in person, bring your ENTIRE bill with you. If we need to reprint a bill, there will be a fee incurred.

# **Sustainable Bethany**

### No. 55. Letter from Sustainable Bethany.

Spring and summer bring powerful storms from thunderstorms, tornadoes, to hurricanes. Records show Connecticut endures a hurricane every 20 years. We suggest a 10-day supply. Many items and actions can be put in place well before an emergency event to avoid last minute panic preparations.

**Documents/signaling/information:** Insurance coverage. Photographic records of home/business, valuable artifacts, and vital records. Secure in safe dry place. Keep in portable document organizers in the event of evacuation. Written important contacts for family, physicians, veterinarians, friends, neighbors. White distress flag. Whistle. Battery power/crank radio with emergency frequencies identified. Local paper maps. Emergency cash.

**Energy:** Fresh gasoline. Generator in good condition. Battery powered lighting. Matches in waterproof container. Grill. Dry firewood. Batteries.

**Hardware:** Plastic sheeting/tarps. Manual can opener. Extra set of car/house keys. Two-way radios. Duct-tape. Plastic gallon bags. Scissors/knife(s). Multi-purpose and/or handyman tools.

# Food (stored in cool, dark, dry place labeled with expirations dates. Monitor and exchange as needed)

Any canned/in-glass processed foods. All grains including rice and pasta. Vegetable oils. Baking powder. Dried beans/lentil products. Coffee/tea/cocoa. Bouillon products. Dried fruit/nuts. Shelf safe fruit juices. 10lbs of bread flour and yeast. Sugar. Milk: powdered, condensed and/or cartons of long-life milk. Care: All hygiene supplies including hand-dishwashing soap,

Care: All hygiene supplies including hand-dishwashing soap, paper towels, toilet rolls etc. Vitamins, protein bars, supplements. Dropper. Medicines, bandages, wraps. Small trash bags. Liquids: Toilet water: 5-gallon buckets to collect from streams, lakes, rainwater, springs. Fresh water: One gallon/person/day. Water purification instructions: Boiling water kills bacteria, viruses, and protozoa. Cloudy water, allow to settle and filter through a clean cloth, or coffee filter. Heat to rolling-boil for five minutes. Let water cool, store in clean covered containers. Improving taste of boiled water: use a pinch of salt/quart water or pour from one clean container to another several times.

Pure unscented bleach – Add 16 drops of liquid chloride bleach/gallon of water. Sodium hypochlorite concentration of 5.25%-06% should be the only active ingredient. No soap or fragrances. Stir and stand for 30 minutes. Information sources: FEMA, Red Cross, WHO.

# It Happened in Bethany By Linda Wooster

### Soap Sculpture in Smithsonian

In 1976, Bethany Sculptress Ann Lehman was commissioned by the Smithsonian Institute to design something "in the spirit and style" of the Philadelphia Centennial Exposition of 1876. Artistic sculptures in soap, cheese, and other exotic materials were in Victorian vogue back then.

Lehman started to shape a half ton block of soap with a power saw when it arrived at her studio home in January 1976. As the general proportions she wanted emerged, she switched to more conventional tools. What evolved after a mass of soap had been cut away was "campy and fun." There was a three-foot high cherub, holding aloft a torch -- --a la Statue of Liberty -- as he rises from a broken eggshell. Two almost life-size eagles, wings partly spread, guarded either side of the base with a swirling American flag.

Lehman's soap block was cast in the carton in which the Colgate-Palmolive Co. shipped it to Bethany. Because of its size, the initial cutting had to be done outside under a polyethylene shelter before it was wheeled indoors to be worked on. The block was made with a 30% moisture content (regular soap is 13%) to ensure greater density and ease of carving.

Lehman and her family used a small van to drive the 400-pound finished work to the Smithsonian Institute in Washington DC at the end of March, where the Institute was preparing for its two-year exhibit which was to open in May of that year.

Lehman noted that some flamboyant sculptures in butter and chocolate at the original 1876 Centennial had to be carved each night to keep outlines firm. Although such repairs appeared unlikely to be necessary for the soap sculpture, the Bethany artist did have problems with "checking" when exposure to air caused some drying and cracking. Spraying the statue with clear spray, plus displaying it under glass at the Smithsonian, was expected to pre-protect it.

Lehman's husband, Albert and her father, Nathan Podoloff, frequently were involved in moving her 500-pound creations, which were often in metal. Examples of her work were showcased at the Fieldhouse Sports Center at Southern Connecticut State College and private collections. She taught metal sculpture at New Haven's Creative Arts Workshop, of which she was first president. Lehman was also an active horsewoman and tennis player.



### From the Assessor's Office

#### RENTERS PROGRAM

Applications for the Renters Program may be filed with the Town's Assessor between April 1, 2025 and September 30, 2025. Those residents of Bethany who:

Have attained the age of 65 on or before 12/31/2024, Hold full-time residence in Bethany, Total income does not exceed \$45,200 for a single person or \$55,100 for a married couple. Those on social security disability are exempt from the age requirement.

Applications can be mailed to the Assessor's Office, Town Hall, 40 Peck Rd, Bethany, CT 06524 by September 30, 2025. Proof of 2024 income and social security earnings (SSA-1099) is REQUIRED ALONG WITH RECEIPTS OF ALL 2024 RENT AND 2024 UTILITIES (exclusive of phone & cable). Those persons who had applied for this program last year will be mailed an application in April 2025.

### ADDITIONAL VETERANS AND LOCAL VETERANS

**EXEMPTION-** The additional veteran's and local veteran's exemptions are available to qualified veterans who meet certain income requirements. These two programs provide an increase in assessment reduction beyond the standard veteran exemption. The deadline for filing applications is September 30, 2025. Applicants must meet an income requirement of not more than \$45,200 if single, and \$55,100 if married to qualify for the State of Connecticut Additional Veteran's Program. The income limit for the Town of Bethany Local Option Additional Veterans Exemption is \$70,200 for single applicants and \$80,100. Income includes adjusted gross income plus any other income, including Social Security benefits. Income is based upon the 2024 calendar year. Federal Income Tax return and/or proof of all income must be presented to the Assessor's office which is open Monday through Friday 8:30 am and 4:00 pm. Please remember that all proof of income, including Social Security benefits (Form SSA-1099) for the 2024 calendar year must be submitted by September 30, 2025, or the application cannot be processed.

Ali Beres-Nork, 2025 Conservationist of the Year!!!

At the May Town Meeting, Ali Beres-Nork was recognized as Bethany's 2025 Conservationist of Year. Presented each year by the Conservation Commission, the award recognizes excellence in environmental protection or significant



contributions to the advancement of conservation. Nominated by one of her students at Amity High School, Ali is an environmental science teacher, passionate about inspiring a love for science and the natural world. Her students have volunteered to clear invasive plants from Bethany's trails and they help maintain the campus pollinator garden she created. She has also created a food rescue initiative through which thousands of pounds of donated school cafeteria food and drink have been given to Haven's Harvest, an organization dedicated to reducing food waste. Ali also serves as a member of the Bethany Conservation Commission, the Sustainable Bethany Committee and the Bethany Land Trust Board of Directors. As a CT State Master Naturalist, Ali leads hikes and delivers lectures on ecology and natural history. She holds two master's degrees, one in science education and the other in Land Resources and Environmental Sciences. Currently, she is seeking her PhD in Education, with a focus on experiential learning in Environmental Science at the University of Idaho.







### LATE DOG LICENSES

A late fee of \$1 per month applies to applications received after June 30th. The fee for licensing in JULY is now \$20 for unaltered Male or Female dogs and \$9 for Spayed or Neutered dogs and will increase by \$1 in August.

**Proof of rabies vaccination** is required when licensing your dog. If this is the first time licensing your dog, or your dog was recently fixed, **proof of spay or neuter** is also required.

Dog Licenses may be renewed in person in the Town Clerk's Office or by printing and mailing the Dog License Application/Renewal Form from




