PROJECT UNDERSTANDING AND APPROACH

Brosnan Risk Consultants is submitting this proposal in response to the Town of Bethany, Connecticut's request for an independent review of the town's response to unfortunate allegations that children in the Parks and Recreation Department's aftercare program having been sexually abused by one of the Park and Recreation Department counsellors.

A parent of one of the victim's filed a report with the Department of Children and Family Services (DCF), in December of 2022. The residents of the Town did not become aware of this serious complaint until the Connecticut State Police issued a Press Release in June of 2024, announcing an arrest warrant relative to five incidents of sexual abuse, charging former Parks and Recreation's counsellor, Anthony Mastrangelo, with the offenses. A critical focus of our investigation will determine what agencies were notified of these serious allegations, when they were notified, and what was the response of agency and Town officials when they were made aware of these complaints. Of equal importance, and focus of our inquiries, will be whom should have been notified, and if there was a failure or breach of policies, laws, or regulations, to highlight the nature of the breach, and who was responsible for the breach. To illustrate the Town's concern, and the urgency of this independent review, DCF immediately notified the Bethany Community Schools of the parent's report, and the DCF notified the Park's and Recreation Department of the allegation involving their employee, Anthony Mastrangelo. Our investigation will validate or refute the timing of these notifications and determine why there was a gap in the knowledge of the Town's officials. Additionally, the Town's handling of the accused employee, upon notification, will be scrutinized, particularly since another child was abused by the former employee in June of 2024.

BRC is uniquely qualified to handle this investigation on behalf of the Town of Bethany.

John Ryan, an attorney and member of the bar is the SVP of Investigations for BRC, was formerly the President and CEO of the National Center for Missing and Exploited Children. During his tenure at NCMEC, John led a nationwide initiative to partner with nonprofit and municipal agencies that ran youth-oriented programs and develop safety and compliance programs to prevent and respond to sexual abuse of children in their care. Working with organizations such as the Boy Scouts of America, the Boys and Girls Club, and Parks and Recreation in Baltimore and New York, Mr. Ryan developed model programs for youth-oriented programs for other agencies to implement. John will lead this investigation on behalf of the Town of Bethany, if retained.

In addition, Brosnan Risk Consultants will bring three experienced investigators to support this investigation:

Mike Carroll, who previously was an executive with the NYC Department of Investigations, has participated in numerous municipal focused inquiries involving sexual assault and misconduct, particularly with a major school district within the state of Connecticut. These investigations not only included investigating the specific allegations, but also included extensive reviews of policies and procedures to identify gaps and vulnerabilities that might have contributed to the misconduct, i.e., lack of training, insufficient background checks, poor interagency communication, etc.

Tom Murray, BRC's Director of Investigations, previously served as a Sergeant with the Connecticut State Police and has handled sexual abuse cases. As the Acting Commanding Officer of the Statewide Organized Crime Investigative Task Force, he managed and supervised investigations funded by a \$500,000.00 Federal Human Trafficking Grant. This grant helped fund numerous Sex Tracking Investigations.

Armando Rodriguez, BRC's Vice President of Investigations, is a former First Grade Detective with the NYPD, and along with Tom Murray, will conduct the bulk of the interviews relating to the inquiry.

Throughout the interview process, John Ryan and Mike Carrol will be examining the relevant laws, regulations and policies, that should have been complied with based on the allegations in this matter. We will also identify gaps in existing procedures, and make recommendations to consider either legislation, policies, or procedures, to adopt after the investigation. We will work closely with Selectmen Robert Brinton and Gina Teixeira, coordinating our plan of action, providing updates on developments, and providing a preliminary report outlining any immediate concerns and initial findings. We are very sensitive to the concern of many that there was a breakdown of overall communications in this matter, we will ensure that our work will be shared appropriately and the lines on communication constantly open.

Our Final Report will focus on recommendations to assist the Town in addressing any deficiencies in laws, regulations, or policies, that contributed to any breakdown in the Town's response to the allegations involved in this matter. We have extensive experience in partnering with organizations to develop programs focusing on child protection. Recommendations will include a review of the screening and hiring process of volunteers and staff that interact with youth. We will review and make recommendations on robust safety programs and training to prevent, detect, and report allegations of sexual abuse. Compliance programs mandating incident response and notifications will be addressed. Our goal is to assist the Town of Bethany to implement policies and procedures to mitigate the reoccurrence of the tragic incidents that commenced in December of 2022 through June of 2024.
